## Life Membership is Categorized in 3 Parts

- (ii) Right to Contest and Vote in Regional & National Election.
- (iii) Promotion for Introduce (iv) State/National Unit Post

1. Members will be responsible for the incorrect / incomplete declaration made in the membership application form, for which their Eviction / necessary action will be taken against him.
2. The Members and Officers of ACCI are working on voluntary basis and no payment is given to them. This post is completely selfless and honorable. Please do not expect any kind of salary / service consideration.
3. Membership is non-transferable and once the payment is made, it is non-refundable.
4. Any kind of misbehavior or misconduct may result in rejection of membership of ACCI. Conduct or indiscipline in criminal activities or contrary to organization constitution and rules. If done, the post and membership will be terminated. All disputes subject to jurisdiction of Delhi.
5. After receiving the nomination, its veracity can be checked from the organization's website or head office. Can. In addition to the head office, the nomination papers / address letters will be invalid. Whose information please will give to the administration & ACCI Head Office.
6. Membership of any other parallel / organization is prohibited.
7. The policy of the Organization has to be strictly followed.
8. The nomination process may take from 45 days to 60 days. The nomination process will be possible only after the report and recommendation of the office. The National Executive can take its own decision if any report / recommendation or post is not agreed upon. The National Executive reserves all its rights. The officer will be promoted on the basis of his / her respective office report.
9. ACCI will not be responsible for any misuse of identity Card issued to the Membership during the course of their Membership with ACCI.
10. On expiry, end of the committee or upon its removal from the organization, the Identity Cards must be submitted to the ACCI Head office. After expiry, renewal is a must for regular membership.
11. In case of change of address / mobile no Member should inform the same to the ACCI Head office.
12. In case of loss the identity Card, inform the ACCI Head Office in writing along with the F.I.R. immediately.
13. All ACCI members should contact their respective Area Units / State Units / National unit office once in a month.
14. Applicant can use photocopy of the application form which will be duly acknowledged by the National Head Office once received duly filled in.
15. Strict action will be taken against the Member, if found guilty violating the rules and regulation of ACCI.
16. If you have any doubt, question or problem, please contact ACCI Head office. All rights reserved to ACCI.
17. If any ACCI officer asks for a higher fee for membership then complain to the national office or high official do it immediately.
